Shaanxi University of Chinese Medicine 2026/2027 Academic Year International Student Enrollment Guide

I. University Profile

The predecessor of Shaanxi University of Chinese Medicine (SUCM) was the Northwest Traditional Chinese Medicine Training School established in Xi'an in 1952. It was upgraded to Shaanxi College of Traditional Chinese Medicine in 1959 and relocated to the ancient capital Xianyang in 1961. It was designated as one of the eight key TCM institutions in China under Document No. 56 issued by the CPC Central Committee in 1978. SUCM began enrolling postgraduate students in 1978 and became one of the first institutions authorized to confer master's degrees in 1981. It was renamed Shaanxi University of Chinese Medicine in 2015. In 2021, it became a co-construction university by the Shaanxi Provincial People's and the National Administration of Government Traditional Chinese Medicine. In 2022, it was approved by the Ministry of Education to become a member unit of the "China Joint Graduate School of Traditional Chinese Medicine." In 2024, SUCM became a doctoral degree-granting unit and was listed as a National

High-Quality Undergraduate University. In 2025, it was granted the qualification to be recommended as an outstanding undergraduate graduate for admission to postgraduate studies without entrance examination. After over 70 years of development, SUCM has evolved into a medical university focusing on TCM education, while emphasizing the integration of Traditional Chinese and Western Medicine, and supporting interdisciplinary collaboration among Medicine, Science, Engineering, Liberal Arts, and Management.

(III) Other Fees

- 1. Insurance:Based on the current national standards and designated insurance company rates. For degree students, the premium is approximately 800 RMB/person/academic year.
- 2. Self-funded Expenses: Round-trip international travel, physical examination, visa fees, as well as expenses for meals, accommodation, transportation, and medical care during the study period in China.

IV. Application Eligibility & Requirements

(I) Applicants must be at least 18 years old, hold a high school

diploma or above, with good academic performance.

- (II) Applicants must be in good physical and mental health, free from contagious diseases or any conditions that may hinder normal study, and capable of sustaining normal study and life in China.
- (III) According to the Nationality Law of the People's Republic of China, applicants must be non-Chinese citizens holding a valid ordinary passport.
- (IV) According to the regulations of the Ministry of Education, overseas Chinese applicants for study in China must hold a valid foreign passport or nationality certificate for at least four years (inclusive) and have a record of actual residence abroad for more than two years within the last four years.
- (V) If both or one of the applicant's parents is a Chinese citizen, the following documents must be provided (choose one):
 - 1. Proof that the applicant acquired foreign citizenship at birth; or
- 2. For applicants who were former Chinese citizens and subsequently obtained foreign citizenship: proof of cancellation of original Chinese household registration and proof of withdrawal from Chinese nationality.
- (VI) Applicants must be friendly towards China, have good moral character, no record of disciplinary violations, administrative

penalties, or criminal offenses, and comply with Chinese laws and regulations as well as university rules, respecting Chinese customs. (VII) Starting from 2026, all applicants for undergraduate programs are required to take the China Scholastic Competency Assessment (CSCA) organized by the China Scholarship Council.

V. Application Documents

(I) Basic Documents

- 1. SUCM International Student Application Form.
- 2. Scanned copy of passport (valid for at least 6 months from the application date). Applicants currently residing in Mainland China must also provide a scanned copy of their current valid visa or residence permit page.
- 3. Scanned copies of highest diploma/degree certificate and academic transcripts.
- 4. Certificate of No Criminal Record (valid within 6 months).
- 5. Foreigner Physical Examination Form (valid within 6 months).
- 6. Proof of financial support (bank statement).
- 7. Personal Statement and Study Plan (approx. 800 words).
- 8. Digital Photo: Recent passport-sized, bareheaded, full-face photo with white background (no borders), head covering 2/3 of the photo size. Minimum 320*240 pixels, aspect ratio 4:3, file size

100-500KB, JPG format, named after passport number.

(II) Required Supplementary Documents

- 1. Undergraduate Applicants:
- (1) Scanned copy of HSK Level 4 certificate.
- (2) Score report for the CSCA, or screenshot of exam registration confirmation (registration no later than April 2026). Final scores must be submitted by May 31, 2026.
- 2. Master's Degree Applicants:
- (1) Scanned copy of HSK Level 5 certificate.
- (2)Two recommendation letters from associate professors or higher in relevant fields.

*Note:

The university may request additional documents if necessary. All certificates and documents must be in English or Chinese. Documents in other languages must be accompanied by notarized English or Chinese translations.

VI. Application Procedure

Step 1: Take the CSCA (Undergraduate Applicants only)

Undergraduate applicants must take the CSCA organized by the China Scholarship Council and obtain a score report. Please check the official CSCA website (http://www.csca.cn)) for specific test dates and content. Test subjects are suggested as follows:

Step 2: Submit Application Documents

- 1. Applicants should download the SUCM International Student Application Form from the School of International Education website.
- 2. Submit scanned copies of all application documents to the admissions email gjy@sntcm.edu.cn by May 31, 2026.

Step 3: Review & Admission

- 1. The university will review the completeness and authenticity of application materials and conduct a comprehensive evaluation (Master's applicants may require written tests and interviews) to determine the admission list.
- 2. Applicants must check their email regularly and provide supplementary information or documents as requested based on the application review feedback.

Step 4: Issuance of Admission Documents

Admitted students will receive the Admission Notice and the Visa Application for Study in China Form (JW202). Students can

download the electronic JW202 form via the Visa Assistant section on the Study in China website (http://www.campuschina.org)).

Step 5: Visa Application & Registration

- 1. Admitted students should take their ordinary passport, Admission Notice, Visa Application for Study in China Form (JW201/JW202), original Foreigner Physical Examination Form, and all original ancillary medical reports (valid for 6 months) to the Chinese embassy or consulate in their home country to apply for a Student (X1) Visa. They must report to SUCM by the date specified in the admission documents and apply for a residence permit within 30 days of entry into China.
- 2. The registration period is generally from September 1 to September 30, 2026 (specific date subject to the Admission Notice). Those who fail to report by the deadline without prior approval will be considered to have forfeited their admission and any scholarship eligibility. Early registration is generally not accepted.
- 3. Upon registration, the following original documents must be presented for verification:
- (1) Passport
- (2) Copy of Admission Notice

highest diploma/degree certificate and academic (3)Original

transcripts

(4) CSCA score report (Undergraduate applicants)

(5) Original physical examination and blood test reports

*Notes:

1. All documents listed above must be in English or Chinese; documents in

other languages must be accompanied by notarized English or Chinese

translations.

2. Failure to provide required original documents, or discrepancies between

originals and scanned copies submitted during application, will result in

revocation of admission.

3. Discrepancies between the physical examination records and the

applicant's actual health condition will result in revocation of admission.
